A Common Challenge

Among the shared challenges we face is the erosion of democracy.

Social inequalities are on the increase everywhere. The climate is in crisis. Alternative authoritarian forms of government are emerging. Digital media is bringing about structural changes to democratic publics, leading to the fragmentation of communication.

Amongst the variations of democracies globally, a **common thread** is the inclusion of citizens within political decision-making as well as deliberation, participation, and accountability.

For democracy to be revitalised, all citizens and citizens-to-be need to be empowered to build their own designs for transformation.

Towards the Future

A year after the **New Africa-France Summit** that was held in Montpellier, France, to examine the relationship between Africa and France, a new framework for reflection and action has been co-created.

A cycle of regional forums entitled "Our Future - Africa Europe Dialogues" will be co-organised by the French Institute in Paris, local partners in African countries, and the French cultural network over the next 3 years.

The first forum of this cycle, **free** and **accessible** to all, titled "**Paths to Democracy**", will take place in Johannesburg, South Africa, with the second in Yaoundé, Cameroon and the third in Algiers, Algeria.

The forum will run parallel to the launch of the **Innovation Foundation for Democracy,** whose head office is in Johannesburg. The Foundation has been established to educate, inform and capacitate the youth to reflect on democratic change in Africa, France, and Europe.

A number of efforts to revive democratic principles on the African continent are unfolding. There is a renewed focus on subjects such as inclusion, participation, transparency, and accountability. There is a need to open the discussion to a wider body of activists, intellectuals, community organizers, and advocacy groups, so that the solutions to democratize the future reflect the diversity of the people who will experience it.

This Forum recognises the need for a transformation in the way democracy is looked at. This change requires the questioning of inherited ways of thinking about democracy and forging routes to new models.

A **co-constructed and innovative** programme, **open** and **free** to all, has been designed to include all local and international perspectives, of all ages, coordinated by the French Institute of South Africa.

The participation of young voices, starting from as young as 6 years old, will be essential to pinpointing the way forward.

A Collaborative Public Programme

On the 7th and 8th October an inter-continental movement will take place around Johannesburg and Soweto. Passing through iconic sites from Soweto Theatre to Constitution Hill, democracy and all the ways to reach it will be explored.
